- 1) Meeting: Called to order by Supervisor Scott Luostari at 6:43 pm.

- 3) <u>County Supervisor</u>: no new information.
- 4) <u>Town board reports</u>: Jon Winter new supervisor. All officers already sworn in.
- 5) <u>Approval of minutes</u>: Scott motioned to have the 3/10 town meeting minutes approved as presented Scott seconded, carried at 6:47 pm.
- 6) <u>Treasurer report:</u> Tracy presented the treasurer report. Jon motioned to accept the treasurer report as presented, Scott seconded, carried 6:48 pm.
- 7) <u>Confirmation of March revenues and expenses</u>: Scott made a motion to approve the March checks 20375–20402 + 2 EFT's, Jon seconded, carried at 6:50 pm.
- 8) <u>Current bills for payment</u>. Checks 20408-20435 presented for payment approval. Jon motioned to accept, Scott seconded motion to pay the bills carried at 6:51 pm.

## **Department and Committee Reports**

- 10) <u>Fire department</u>: Presented by Chief Nova, there was a wild land fire that burned close to 2 acres, the FD got to try out the equipment they had purchased for that scenario. The FD golf tournament will be on 5/16/15. The annual "Be Somebody" campaign will be 5/30/15 in Brule starting at noon. We will also be supplying Medical standby for the Shrine Circus, the circus also gives prizes to children through drawings at the Circus, and the FD will provide a donation as well. 1<sup>st</sup> responders reply to FD related scenarios as 1<sup>st</sup> responders, no matter what their full time job classification/qualifications might be, town will not provide extra insurance other than the first responder role. Lakeside hosts the May Association meeting, on the 18<sup>th</sup>. Reminder to everyone that it is wild fire season and to be careful with any sort of outside fires as the conditions are extremely dry.
- 11) <u>Town Employees/Roads</u>: Mark- grading roads, hauling gravel and fixing roads. Culvert moved on Halkett road. Still have illegal dumping at the collection site, we have also contacted area Towns where some of the known offenders live, to work on getting the issue stopped. Still working with Enbridge on getting Camp Amnicon road repaired from their damage. Road Survey to be set up for Monday April 27<sup>th</sup> 6:30 pm, still missing roads signs, and those ordered 3 weeks ago still have not arrived.
- 12) <u>Building Permits and Zoning issues</u>: The County is looking to change their ordinance regarding zoning of salvage yards. A motion was made by Tom Johnson for the Town of Lakeside to approve the Salvage Ordinance provided by the county, **With the stipulation** that Jeremy Winans aka Lakeside Trucking, be grandfathered in, and exempt from these new changes. Motion seconded by Scott Luostari, motion carried 7:42 pm.
